BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a portion of Pueblo Lot 1274, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the County Recorder of said County, November 14, 1921 and is known as miscellaneous Map No. 36, as more particularly described in the document attached hereto as Exhibit A and incorporated herein, is hereby set aside and dedicated as and for a public street, and the same is hereby named TULA COURT.

That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.

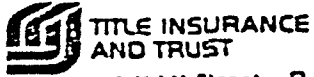

ALL THAT PORTION OF PUEBLO LOT 1274, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO MAP THEREOF MADE BY JAMES PASCOE IN 1870, A COPY OF WHICH SAID MAP WAS FILED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY, NOVEMBER 14, 1921 AND IS KNOWN AS MISCELLANEOUS MAP NO. 36, DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST WESTERLY CORNER OF LOT 294 OF UNIVERSITY VILLAGE UNIT NO. 4, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO MAP THEREOF NO. 6402, FILED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY; THE WESTERLY LINE OF SAID LOT BEARS SOUTH 0°57'06" WEST (RECORD SOUTH 0°54'08" WEST) TO SAID MOST WESTERLY CORNER; THENCE NORTH 66°47'44" WEST 317.02 FEET TO THE TRUE POINT OF BEGINNING; THENCE CONTINUING NORTH 66°47'44" WEST 9.39 FEET TO THE EASTERLY LINE OF GULLSTRAND STREET AS CONVEYED TO THE CITY OF SAN DIEGO BY PARCEL 1 OF DEED RECORDED JULY 6, 1962 AS DOCUMENT NO. 115528 OF OFFICIAL RECORDS; THENCE SOUTH 9°03'21" WEST ALONG SAID EASTERLY LINE 19.07 FEET TO A POINT OF CUSP WITH A 20.00 FOOT RADIUS CURVE CONCAVE SOUTHEASTERLY, A RADIAL OF SAID CURVE BEARS NORTH 80°56'39" WEST TO SAID POINT; THENCE NORTHEASTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 57°00'14" AN ARC DISTANCE OF 19.90 FEET TO THE TRUE POINT OF BEGINNING.
