RESOLUTION NO. 220371

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That American Television and Communications Corporation (Southwestern Cable TV) be and it is hereby authorized to increase its monthly subscriber rates, except for the area serviced by the Rancho Bernardo Antenna Systems, Inc. Franchise, by seventeen cents (17¢) per month for subscribers receiving 20 channel service and fifteen cents (15¢) per month for subscribers receiving 12 channel service, with an additional three cents (3¢) per outlet for subscribers with more than one outlet in order to pass through to subscribers the compulsory copyright license fees which American Television and Communications Corporation will be required to pay pursuant to Public Law 94-553 (the Copyright Act of 1976), a Federal statute which became effective on January 1, 1978, provided that said additional charge is clearly set forth on American Television and Communications Corporation's billings to customers as a separate charge mandated by Federal law and is not an increase in City approved CATV rates.

BE IT FURTHER RESOLVED, that American Television and Communications Corporation be and it is hereby authorized to increase its monthly subscriber rates for the area serviced by the Rancho Bernardo Antenna Systems, Inc. Franchise by twelve cents (12¢) per month for subscribers receiving 20 channel service,

including two outlets, and ten cents (10¢) per month for subscribers receiving 12 channel service, including two outlets, with an additional three cents (3¢) per additional outlets over and above two outlets in order to pass through to subscribers the compulsory copyright license fees which American Television and Communications Corporation will be required to pay pursuant to Public Law 94-553 (the Copyright Act of 1976), a Federal statute which became effective on January 1, 1978, provided that said additional charge is clearly set forth on American Television and Communications Corporation's billings to customers as a separate charge mandated by Federal law and is not an increase in City approved CATV rates.
