BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of McCUNE MOTORS is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TEN (10) COMPACT 4-DOOR SEDANS (Plymouth-Volare). Four (4) of the vehicles for a cost of \$4,464.17 each, and six (6) of the vehicles for a cost of \$4,153.47 each, for a total cost of \$42,777.50; terms net 30 days plus sales tax less trade-in allowance as follows: 1-1965 Chevrolet Sedan - \$70.00; 1-1968 Chevrolet Sedan - \$70.00; 3-1969 Chevrolet Sedans - \$100.00 each; 5-1970 Chevrolet Sedans - \$180.00 each.
