BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$139,800 from Capital Outlay Fund 245 for the acquisition of land for a fire station site in Lot 4 of Mira Mesa Shopping Center Unit No. 4 and for related costs is hereby authorized and approved.
