BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of GERALD PAUL REDON AND JEANETTE MARIE REDON, husband and wife, executed in favor of The City of San Diego, bearing date of December 7, 1977, conveying to said City an easement for public street over, under, along, and across the Westerly 9.00 feet of the Easterly 42.00 feet of the South One-Half of the Southeast One-Quarter of the Northeast One-Quarter of Section 33, Township 18 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named HOLLISTER STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
