

WHEREAS, Section 3505 of the California Government Code requires that the governing body of a public agency or representatives designated by it shall meet and confer in good faith regarding wages, hours and other terms and conditions of employment with representatives of employee organizations; and

WHEREAS, the City of San Diego's Employer-Employee Relations Policy provides for the appointment of a Management Team by the City Council to represent the City in employer-employee relations pursuant to that Policy; and

WHEREAS, Council Policy 300-1 provides that the Management Team shall meet and confer with employee organizations upon receiving direction from the City Council; and

WHEREAS, on February 6, 1973, the City Council, by Resolution No. 207328, designated the City Manager or his designee(s) as the Management Team; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 207328, dated February 6, 1973, be and the same is hereby rescinded.

2. That Assistant City Manager Ray Blair, Attorney Josiah L. Neeper, Labor Relations Assistant Phil Gardner and Deputy City Attorney David Morris be and they are hereby appointed by the City Council to the Management Team of The City of San Diego in accordance with the City's Employer-Employee Relations Policy and Council Policy 300-1.
