BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to submit two requests to the Comprehensive Planning Organization for the sum of \$203,000 from Local Transportation Funds (LTF) for construction of two bikeways identified as follows:

- 1 - Rose Canyon Bikepath (Phase II) between Gilman Drive and Genessee Avenue (CIP 58-013);
- 2 - Allen Road Bikepath between Hotel Circle South and Fort Stockton Drive (CIP 58-016);

Said bikeways are part of the adopted main bikeway corridor system and are included in the fiscal year 1978 Capital Improvements Program.
