WHEREAS, as a result of such conflagration, an unsafe condition presently exists in the immediate area of the Building; and

WHEREAS, because of the aforesaid condition an emergency exists with respect to the immediate preservation of the public life and safety of the citizens and residents of the City of San Diego; and

WHEREAS, the public interest and necessity demand the immediate expenditure of public monies to safeguard the public life and safety;

NOW THEREFORE,

BE IT ORDAINED by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby authorized to execute an agreement with JOHN HANSEN CONSTRUCTION CO., INC., a corporation, for the demolition and cleanup of the ELECTRIC BUILDING RECONSTRUCTION - PHASE II - DEMOLITION under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 762809.

BE IT FURTHER RESOLVED, that the expenditure of \$22,000.00 is hereby authorized out of federally funded accounts solely and exclusively for the purpose of providing funds for the above referenced services.
