BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of CARL BURGER DODGE is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TWENTY (20) 3/4 TON WINDOW VANS, Dodge B200, at a cost of \$6,605.00 each, terms net 30 days plus sales tax for a total cost of \$140,026.00; less a trade-in allowance of \$2,600.00 each for ten (10) 1977 Ford Econoline E150 vans, total trade-in allowance of \$26,000.00.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$26,000.00 from the Motive Equipment Replacement Fund 5221, program element 8850, to the General Fund 100 Police Department program element 15.24.
