

RESOLUTION No. 220412 (R-78-1588)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. NEPTUNE WATER METER COMPANY 2. BADGER METER, INC. 3. HERSEY PRODUCTS INC. 4. ROCKWELL INTERNATIONAL and 5. GAMON-CALMET INDUSTRIES, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS for a period of one (1) year beginning March 1, 1978 through February 28, 1979 per prices on file in the Purchasing Department as follows:

1. NEPTUNE WATER METER COMPANY for Section II, Items 1 and 2 for turbine meters and for parts for Neptune Meters; terms net 30 days, plus sales tax with an option to renew for an additional one (1) year period, and;

2. BADGER METER, INC. for Section II, Item 3 for turbine meters and Section III, Item 3 for commercial service meters and for parts for Badger Meters; terms net 30 days, plus sales tax with an option to renew for an additional one (1) year period, and;

3. HERSEY PRODUCTS INC. for Section II, Item 4, for turbine meters and for Section IV, Items 1 and 2 for general service meters and for parts for Hersey Meters; terms net 30 days, plus sales tax, and;

4. ROCKWELL INTERNATIONAL for Section II, Item 5 for turbine meters and Section III, Items 1 and 2 for commercial service meters and for parts for Rockwell Meters; terms net 30 days, plus sales tax with an option to renew for an additional one (1) year period, and;

5. GAMON-CALMET INDUSTRIES, INC. for parts for Gamon-Calmet turbine and commercial service meters; terms net 30 days, plus sales tax and freight with an option to renew for an additional one (1) year period.
