BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with STECK AVIATION, INC., a California corporation, as Lessee, for the purposes of operating and maintaining a Fixed Base Operation on Brown Field Airport, which property has an appraised value of \$146,900 as determined by an Independent Fee Appraisal dated April 29, 1977, with an annual fair rental value of \$13,213, under the terms and conditions set forth in that form of lease agreement on file in the office of the City Clerk as Document No. 762891.
