


RESOLUTION No. 220435 (R-78-1657 )

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with PENHALL COMPANY to dispose of sludge in the Old Harbor Drive Sewage Treatment Plant by pumping it through the Metropolitan Sewerage System for a fee to be paid to said City of not less than \$12,000, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 762894.
