
Adopted on MAR 13 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces the conversion of the traffic signal services at Bisby Lake-Navajo Road, at Lake Murray Boulevard-Navajo Road and at Lake Murray Boulevard-San Carlos Drive; the installation of one street light on Lake Murray Boulevard and changing 12 mercury vapor luminaires to high pressure sodium; and performing other miscellaneous work as needed, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

That the expenditure of \$7,400 is hereby authorized from Capital Outlay Fund CIP 37-028 for the sole and exclusive purpose of providing funds for the above-stated work and related costs.
