WHEREAS, The City of San Diego has applied for a grant from the Land and Water Conservation Fund for the Lake Murray, Cowles and Fortuna Mountain Regional Park; and

WHEREAS, procedures for the Land and Water Conservation Fund grant program require that the applicant comply with the provisions of the National Historic Preservation Act of 1966; and

WHEREAS, there may be archeological or historic values in the project area which may be eligible for the National Register of Historic Places; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego will make all reasonable efforts to identify sites on or eligible for the National Register of Historic Places before development of the project area is commenced.

That the site(s) in the project area which appears eligible for inclusion on the National Register of Historic Places will be submitted by The City of San Diego to the State's Office of Historic Preservation on National Register forms for the State Historic Preservation Officer's nomination to the Register.

That The City of San Diego will make every effort to preserve the identified property(s), and if destruction of the values cannot be prevented, mitigation recommendations will be
