
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a representative of the Water Utilities Department is hereby authorized to travel to Atlantic City, New Jersey to attend a meeting of the American Water Works Association Standards Committee on Asbestos-Cement Pressure Pipe, to be held June 26 through June 28, 1978.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$545 within Water Operating Fund 500 from the Unallocated Reserve (69.69) to Water Services Administration (69.11), for the sole and exclusive purpose of providing funds for lodging, travel and miscellaneous expenses.
