BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a flat rate lease with TMY FARMS, a general partnership, consisting of S & H PACKING AND SALES CO., INC., a California corporation, general partner, and HORWATH AND CO., INC., a California corporation, general partner, for the purposes of growing and wholesale marketing of rotational agricultural program of mixed row crops, dairy cattle feed lots and for such other related or incidental purposes as may first be approved in writing by the City and for no other purpose, at a rental for the initial five years of \$25,190.50 payable quarterly to the Office of the City Treasurer, in arrears, beginning June 1, 1978, and payable quarterly after the initial five years in amounts adjusted upward at the expiration of each five-year increment of the lease as provided under the terms and conditions set forth in lease on file in the office of the City Clerk as Document No. 762950.
