RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO, CALIFORNIA, ORDERING CHANGES IN THE
ASSESSMENT AND INDIVIDUAL ASSESSMENTS

(Blackshaw Lane Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code), the Council adopted its resolution of intention, Resolution No. 219864, ordering the City Manager to cause the Report required by said Act to be prepared, and pursuant thereto the City Manager caused said Report to be prepared, consisting of the description and depiction of the proposed improvements, an estimate of the costs and expenses of said improvements, a diagram showing the assessment district, and the proposed assessment of the costs and expenses of the proposed improvements, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 219865 approving said Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, based on the best responsible bids received for the construction of the sewer improvements, the actual costs differ from the estimated costs, as set forth in said Report, and by reason thereof the Council deemed it advisable to change the amounts of the total assessment and individual assessments and

therefore adopted Resolution No. 220276, declaring its intention to order said changes and appointed a time and place of hearing thereon; and

WHEREAS, the hearing on the Report was continued to the time of the hearing on said changes; and

WHEREAS, the Council adopted Resolution No, 220277 directing the Clerk to give notice inviting bids for the purchase of bonds to be issued to represent unpaid assessments, and, pursuant thereto, bids were received and opened prior to the time set for said continued hearing; and

WHEREAS, said hearing has been held on said proposed changes all in the manner and form prescribed by law, and the Council now having jurisdiction to order said changes,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego as follows:

Section 1. That, based on the best responsible bids for the sewer improvements and for the purchase of the bonds, and on the evidence presented at said hearing, the public interest, convenience and necessity require that the changes hereinafter referred to be made in connection with the proceedings herein referred to, and any and all protests or objections thereto are hereby overruled and rejected.

Section 2. The Council hereby orders that the amounts of the individual assessments and the total amount of the assessment be changed in accordance with the "SCHEDULE OF CHANGES"

attached hereto and made a part hereof, and the Superintendent of Streets is authorized and directed to change the assessment, as filed with the City Clerk, in conformance therewith.
