RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO AWARDING CONTRACT FOR CONSTRUCTION OF
SEWER IMPROVEMENTS

(Blackshaw Lane Assessment District)

WHEREAS, the Council on December 14, 1977, adopted Resolution No. 219864, directing the City Clerk to give notice inviting sealed bids and proposals for certain sewer construction work described therein, and said notice was duly given as provided by law; and

WHEREAS, on January 31, 1978, all sealed bids and proposals for said sewer construction work were publicly opened and examined and a report of the results of the bidding was submitted to the Council; and

WHEREAS, it appears that the lowest responsible bidder was M. Arrieta & Son, Inc.;

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Section 1. The Council hereby awards the contract for the construction of said sewer improvements to the lowest responsible bidder, to wit: M. Arrieta & Son, Inc.

at the prices named in the bid of said bidder on file in the office of the City Clerk of The City of San Diego.
