BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City's contribution of \$262,000 is hereby authorized for the improvement of BLACKSHAW LANE BETWEEN ITS WESTERLY TERMINATION AND SOUTH VISTA AVENUE, as more particularly described in Resolution of Intention No. 219864 and pursuant to the Municipal Improvement Act of 1913.

BE IT FURTHER RESOLVED, that the expenditure of \$249,000 be hereby authorized out of 3rd Year Community Development Block Grant Fund (2930), including \$13,000 from those funds previously authorized from Federal Revenue Sharing Funds, Resolution No. 214699, to be used solely and exclusively for the purpose of providing funds for the City's contribution.
