RESOLUTION NO. 220478

WHEREAS, on February 22, 1978 a fire of apparent incendiary origin occurred to the Electric Building in Balboa Park and on March 8, 1978 a fire of apparent incendiary origin occurred to the Old Globe Theatre in Balboa Park; and

WHEREAS, said fires caused damage and loss to the City in the millions of dollars; and

WHEREAS, members of the San Diego Fire Department sustained injuries in fighting both of these fires; and

WHEREAS, the residents of the City of San Diego are apprehensive and concerned about the real possibility that an arsonist or arsonists are loose in the City causing injuries to people and damage to property; and

WHEREAS, the series of these reprehensible crimes must be brought to a halt as soon as possible for peace, health and welfare of the residents of this City; and

WHEREAS, intensive police activity to apprehend the suspect or suspects continues, and the offer of a reward for information leading to the determination of the identity of, and arrest and conviction of, the criminal or criminals may be a substantial contributing factor to the eventual solution of these crimes and apprehension of suspects; and

WHEREAS, this City Council desires to offer a reward of \$5,000 for information leading to the identity of, and

arrest and conviction of, the person or persons responsible for setting these fires in Balboa Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That in the matter of the recent fires to the Electric Building and Old Globe Theatre in the City of San Diego and which are presently under investigation by the San Diego Police and Fire Departments, the San Diego City Council does hereby find that

- (1) The immediate peace, health and safety of the residents of the City are endangered by the unprovoked commission of said acts;
- (2) These acts, by their nature and frequency, and their unsolved status, have concerned and continue to concern significant segments of the population and such persons will continue to be concerned until the responsible person or persons are identified and apprehended;
- (3) These acts are of substantial local concern and the repeated nature thereof continues to present a serious and immediate danger to the peace, safety and general welfare of the City and are a menace to the rights of its citizens; and
- (4) It would assist and be consistent with the promotion of peace, safety and general welfare of the population and law enforcement in San Diego for

MICROFILMED 220478 01371 the City to offer a reward for the supplying of information resulting, to the satisfaction of the City Council, in the identification, arrest and conviction of the person or persons responsible for the fear and concern of the residents of the City resulting from felonious acts presently being investigated by the San Diego Police and Fire Departments concerning said fires in Balboa Park.

BE IT FURTHER RESOLVED, that a reward in the sum of \$5,000 is hereby offered to any person not an officer or employee of The City of San Diego or officer or employee of any business contracting with The City of San Diego to provide private security services to the City or member of the immediate family of such officer or employee of The City of San Diego, or said business, for the identity and information resulting in the arrest and conviction of any person or persons who have committed the act of arson to the Electric Building or Old Globe Theatre in Balboa Park. Said offer of reward shall be acceptable and payment thereof shall be authorized only upon complete performance by the offeree by establishing the identity of and furnishing information resulting in the arrest and conviction of the person or persons responsible for such illegal acts. The determination whether complete performance has been made shall be made solely by the City Council based upon relevant and material evidence. This reward shall be payable only once and limited to the amount of \$5,000.

BE IT FURTHER RESOLVED, that this offer of reward may be withdrawn at any time by resolution of the Council, and unless sooner withdrawn, shall expire, be withdrawn and be

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is directed to transfer the sum of \$5,000 from the Unallocated Reserve Fund 100, Activity 53.30, to a special account to be created for the purpose of said reward.

BE IT FURTHER RESOLVED, that the City Clerk is directed to immediately cause this offer of reward to be published in at least one newspaper of general circulation in the City.
