WHEREAS, on September 6, 1977, the Redevelopment Agency of The City of San Diego adopted Resolution No. 345 calling for the formation of a Project Area Committee (PAC) for the Gaslamp Quarter Redevelopment Project; and

WHEREAS, in accordance with the directions of the Redevelopment Agency as contained in the resolution, notices were distributed or mailed to all residences, businesses and community organizations within and operating within the boundaries of the proposed project area, advising the recipients of a meeting scheduled for September 29, 1977, 5:00 P.M. in Room 2000 in the City Administration Building, for the purpose of forming a Project Area Committee (PAC); and

WHEREAS, on September 19, 1977, the Notice of Public Meeting for Formation of a Project Area Committee for the Gaslamp Quarter Redevelopment Project was published in the SAN DIEGO UNION, a newspaper of general circulation within the proposed project area and within the City; and

WHEREAS, on September 29, 1977, at 5:00 P.M. in Room 2000 in the City Administration Building, a public meeting was conducted to form a Project Area Committee for the Gaslamp Quarter Redevelopment Project; and

WHEREAS, at said September 29, 1977 meeting, members of the Project Area Committee were duly elected by the residents, businesspersons (and owners of investment property), and representatives of community organizations in attendance; and

WHEREAS, information has been presented to the City Council by the Project Area Committee establishing the qualifications of each person and of the Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Gaslamp Quarter Redevelopment Project Area Committee (PAC), formed on September 29, 1977, and consisting of the persons named on the list of PAC members attached hereto, labeled Exhibit A and by this reference made a part hereof, is hereby approved as presently constituted as a representative project area committee including persons who are residents, businesspersons (including owners of investment property) and representatives of community organizations within the Gaslamp Quarter Redevelopment Project.

2. That the Redevelopment Agency and its staff are directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing for those who may be displaced by Project activities and other matters which affect the residents of the Project area while preparing a Redevelopment Plan and for a period of three years after adoption of the Plan.
