

RESOLUTION NO. 220486 (R.78-1750)

March 20, 1978

A RESOLUTION ORDERING THE FORMATION OF
SAN DIEGO OPEN SPACE PARK FACILITIES
DISTRICT NO. 1.

WHEREAS, at a meeting of this Council duly held on the 25th day of January, 1978, by a vote of more than two-thirds of its members, it passed its Resolution No. 220133 entitled A Resolution of Intention to Form San Diego Open Space Park Facilities District No. 1, wherein it fixed March 20, 1978, at the hour of 2:00 P.M. in the Council Chambers, Charles C. Dail Concourse, 202 C Street, San Diego, California, as the time and place when and where it would hear persons interested in the formation of the district or in the inclusion of any lands therein, and consider and finally act on the formation of the district; and

WHEREAS, said resolution provides that the boundaries of said district shall be coterminous with the boundaries of the City, and that the district was being formed for the purpose of submitting to the voters of the district a proposition of incurring a bonded indebtedness to provide funds for the acquisition of open space and other park facilities; and

WHEREAS, notice of said hearing has been given by publication, posting and mailing in the manner and for the times provided in the Municipal Code and other applicable laws, as evidenced by affidavits and/or certificates thereof on file with the City Clerk; and

WHEREAS, 82 owners of property within the proposed district, up to the hour fixed for the hearing, filed with the City Clerk written statements signed by them stating the grounds on which they are for or against the formation of the district or why their properties will or will not be benefited by being included therein, and 0 of such persons appeared at the hearing and presented evidence in support of their written statements; and

WHEREAS, proofs, oral and documentary, have been submitted in support of the statements and determinations in said resolution of intention and as to each of said statements in relation thereto; and

WHEREAS, the Council has been fully informed in the premises and has duly considered all matters relating to the formation of said proposed district; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The public interest and convenience require the acquisition of open space and other park facilities, pursuant to the San Diego Park Facilities Procedural Ordinance.

2. All protests against the formation of the park facilities district, and all requests for the exclusion of any lands from the proposed district, and each and all of the grounds in support thereof, are overruled.


3. Each and every parcel of land within the City will be benefited by the proposed acquisitions and by being included within the proposed district and no parcel of land within the City will not be benefited by the proposed acquisitions or by being included within the proposed district.

4. A park facilities district is formed, entitled San Diego Open Space Park Facilities District No. 1, and its boundaries are coterminous with the exterior boundaries of the City.

5. This resolution, together with the names of the members of this Council voting for and against it, shall be spread upon the minutes of the Council meeting at which it is adopted.

6. Certified copies of this resolution, together with copies of the map entitled Map of Boundaries of San Diego Open Space Park Facilities District No. 1, San Diego County, California, referred to in said resolution of intention, shall be filed in the office of the County Assessor, the County Clerk and the State Board of Equalization.
