That the petition for the construction of certain improvements of the ALLEY in BLOCK 139, CITY HEIGHTS (Redwood Street-Quince Street-38th Street-39th), under the provisions of the Improvement Act of 1911, consisting of 2 sheets and filed under Document No. 762994, is hereby granted.

That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY, BLOCK 139, CITY HEIGHTS, in the City of San Diego, by the grading and paving as an alley section, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
