
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of USF LIQUIDATING CORPORATION, a Delaware corporation, executed in favor of The City of San Diego, bearing date of December 9, 1977, conveying to said City Lots 11 and 12, Block 14, Floral Terrace, according to Map thereof No. 1635, filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named BERYL WAY.

BE IT FURTHER RESOLVED, that the transfer of \$21,000 from the Gas Tax Unallocated Reserve to CIP 39-004 and the expenditure of not to exceed said \$21,000 for land acquisition for Soledad Mountain Road Project are hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
