
Adopted on MAR 20 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of VELIMIR PETAKOVICH AND LJUBINKA PETAKOVICH, husband and wife, executed in favor of The City of San Diego, bearing date of January 10, 1978, conveying to said City the permanent easement and right of way for a public alley, and incidents thereto, over, under, upon, along and across all that certain real property in the West 18 feet of Lots 15 through 25, inclusive, Block 116 of Morena, as more particularly described in said deed, be, and the same is hereby approved; and that the additional right of way and the existing alley are hereby dedicated as and for a public street, and the same are hereby named MORAVA PLACE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
