BE IT FURTHER RESOLVED, that the expenditure of \$1,500 from Fiscal Year 1978 Revenue Sharing Funds (Fund 267) of The City of San Diego be hereby authorized, solely and exclusively for the purpose of funding production costs of Mainstream Magazine.
