BE IT RESOLVED, by the Council of The City of San Diego as follows:

That this Council hereby intends to authorize and empower the City Manager to execute a second supplemental freeway agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, for the construction of a complete interchange on Interstate Route 15 at Carroll Canyon Road and the improvement of the interchange on Route 15 at Pomerado-Miramar Road in the City of San Diego, as more particularly described in the freeway agreement executed February 27, 1973 and the supplemental freeway agreement executed August 27, 1975, under the terms and conditions set forth in the second supplemental freeway agreement on file in the office of the City Clerk as Document No. 762986.

BE IT FURTHER RESOLVED, that a hearing on this matter will be held on APR 25 1978 at 10:30 a.m. in the City Council Chambers, City Administration Building, 202 C Street, San Diego, California.

BE IT FURTHER RESOLVED, that the Council certifies it has reviewed and considered a Negative Declaration on this matter prepared by the California Department of Transportation as the lead agency under the provisions of the California Environmental Quality Act of 1970.
