

RESOLUTION NO. 220531

(Rev.) MAR 27 1978

WHEREAS, Proposition 13, the Jarvis-Gann Initiative, which will appear on the ballot of the State Primary Election on June 6, 1978, will cut approximately 7.5 billion dollars from schools, cities, counties and other local governments without any provisions for replacement revenues; and

WHEREAS, the loss of 7.5 billion dollars will adversely affect the continuation of essential public services; and

WHEREAS, Proposition 13 provides no specific tax relief for renters; and

WHEREAS, Proposition 13 provides no specific tax relief for senior citizens; and

WHEREAS, the reassessment provisions in Proposition 13 may eventually shift the proportionate share of the property tax burden from businesses to homeowners; and

WHEREAS, the reassessment provisions may bring about unequal and discriminatory taxation; and

WHEREAS, the reassessment provisions may deter capital investments and new jobs in the State; and

WHEREAS, Proposition 13 makes it effectively impossible to approve new bond issues which finance most local construction including schools, streets, sewers, etc.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
