A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE SOUTHERLY HALF OF WALNUT STREET, FROM OTSEGO DRIVE TO FALCON STREET, AND THE WESTERLY HALF OF GOLDFINCH STREET, FROM WALNUT STREET TO BROOKES AVENUE, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San

require the vacation of the southerly half of WALNUT STREET,
from Otsego Drive to Falcon Street, and the westerly half
of GOLDFINCH STREET, from Walnut Street to Brookes Avenue hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of the southerly half of WALNUT STREET, from Otsego Drive to Falcon Street, and the westerly half of GOLDFINCH STREET, from Walnut Street to Brookes Avenue, as more particularly shown on Drawing No. 14082-B on file in the office of the City Clerk as Document No. 763044

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 A.M. MAY 2 1978 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all
