WALLACE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of August 15, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that certain real property known as the Northwesterly 5.00 feet of Lot 60, Empire Addition to Encanto Heights, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named REPUBLIC STREET.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that street easement deed of RALPH W. BOWERS and BONNIE L. BOWERS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of August 15, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that certain real property known as the Northwesterly 5.00 feet of Lot 61, Empire Addition to Encanto Heights, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named REPUBLIC STREET.
