That the City Manager be and he is hereby authorized and empowered to add Capital Improvement Program Fund 61-143 to the Fiscal Year 1978 Capital Improvement Program for the installation of a traffic signal and safety lighting system at the intersection of Santo Road and Shields Street.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$5,400 from the Capital Outlay Unallocated Reserve Fund 245 (CIP 90-245) and \$47,600 from the Gas Tax Unallocated Reserve Fund 219 (CIP 90-220) to CIP Fund 61-143 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced project.
