APPROVING MAP OF LION MIRAMAR INDUSTRIAL PARK  
UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by HENRY L. WORLEY, a Registered Civil Engineer, entitled "LION MIRAMAR INDUSTRIAL PARK UNIT NO. 1 Being a subdivision of portions of Lots 6, 7 and a portion of the East Half of the Southwest Quarter of Section 6, Township 15 South Range 2 West San Bernardino Meridian according to United States Government Survey approved February 19, 1883 on file in the office of the County Recorder of San Diego County, together with Camino Ruiz as dedicated to public use in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Activity Road, Gildred Drive, and a portion of Miramar Road for public purposes; and said streets and portion of a street are hereby declared to be public streets and a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.


