

RESOLUTION No. 220570 (R-78-1753)

Adopted on MAR 28 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Resolution No. 217778 adopted February 23, 1977, by which the City Council elected to continue in the Comprehensive Employment and Training Act (CETA) Program at a participant level of 400 employees is hereby amended to authorize a participant level of 430 positions.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to hire an additional thirty (30) Community Service Officers (CSO) over present budgeted amounts utilizing available CETA funds to provide Police Department patrol of Balboa Park and other assigned duties.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to transfer the sum of \$1,900 from Unallocated Reserve to Police Department Patrol Bureau (15.24) to provide equipment necessary for the increased patrol and related costs.
