Penick & Sons, Inc., a corporation, for CONSTRUCTION OF MORLEY FIELD EAST DEVELOPMENT - PHASE I in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761654.
2. That the expenditure of \$428,000.00 is hereby authorized out of the Park and Recreation Bond Fund 725; that the expenditure of \$107,000.00 is hereby authorized out of the Environmental Growth Fund 2505; and that the expenditure of \$66,000.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MORLEY FIELD EAST DEVELOPMENT - PHASE I in the City of San Diego, and related costs.
