1. That the bid of \$58,654.00 by Griffith Company, a corporation, for IMPROVEMENT OF THE UPAS STREET BIKEWAY SCHEDULE I in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 762752.
2. That the expenditure of \$18,000.00 is hereby authorized out of the Capital Outlay Fund 245; that the expenditure of \$35,000.00 is hereby authorized out of the Local Transportation Fund 2720; and that the expenditure of \$27,000.00 is hereby authorized out of the Capital Outlay Unallocated Reserve Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.


