BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. San Diego Toro 2. Carson Supply Co. and 3. Hydro-Scape Products, Inc. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND SPRINKLER REPAIR PARTS for a period of one (1) year beginning May 1, 1978 through April 30, 1979 per prices on file in the Purchasing Dept. as follows:

1. San Diego Toro for Group I - Toro Sprinklers and Parts; terms 3% 21 days plus sales tax, with an option to renew for an additional one (1) year period, and;

2. Carson Supply Co. for Group II - Rainbird Sprinklers and Parts; terms 2% 10 days plus sales tax, with an option to renew for an additional one (1) year period, and;

3. Hydro-Scape Products, Inc. for Group III - Buckner Sprinklers and Parts; terms 2% 20 days plus sales tax, with an option to renew for an additional one (1) year period.
