BE IT FURTHER RESOLVED, that the expenditure of \$15,750 and \$15,250 is hereby authorized out of Capital Outlay Fund 245 and Gas Tax Fund 219, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
