BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager and the City Attorney are hereby authorized and directed to take steps to terminate agreements between The City of San Diego and the State of California relative to construction of Freeway 252, provided, however, that said City officials are authorized to negotiate a termination which would preclude any monetary damages to the City, and that these termination agreements be approved by this City Council.

BE IT FURTHER RESOLVED, that:

1. The City Manager and City Attorney be instructed to recast our agreements with CALTRANS to explore construction of a major arterial suitable for commercial activity on its borders utilizing the existing State right-of-way;

2. The surplus funds currently slated for Highway 252 should be diverted to construction of badly needed San Diego freeways, and staff is instructed to discuss this with CALTRANS; and

3. Staff will return to Transportation and Land Use with a full report on its actions and invite CALTRANS officials to present its position.
