

RESOLUTION No. 220624 (R-78-1807)

Adopted on APR 4 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the COUNTY OF SAN DIEGO, whereby City leases 24,836 square feet in the County's Ruffin Road facility on a month-to-month basis commencing December 5, 1977, with a 30-day termination clause, at a rental rate of fifteen cents (15¢) per square foot, or \$3,725.40 per month, a copy of which is on file in the office of the City Clerk as Document No. 763177.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$18,026.09 within Fund 100 from the Unallocated Reserve Fund to the Park and Recreation Department, Community Services Division, for payment of rent from December 5, 1977 through April 14, 1978, including an initial payment of \$1,758.51 for building modifications performed by the County.
