A RESOLUTION MODIFYING RESOLUTION NO. 219521 ADOPTED OCTOBER 19, 1977, BY RESCHEDULING THE DATE FOR REMOVAL OF ALL OVERHEAD UTILITY FACILITIES WITHIN THE CAMINO DEL RIO SOUTH (FAIRMOUNT AVENUE TO SCHEIDLER WAY) UNDERGROUND UTILITY DISTRICT.

WHEREAS, this Council did on October 19, 1977 by Resolution No. 219521 establish and designate December 19, 1977 as the date upon which all property within the CAMINO DEL RIO SOUTH (Fairmount Avenue to Scheidler Way) UNDERGROUND UTILITY DISTRICT must be ready to receive underground utility service and March 1, 1978 as the date upon which all overhead utility facilities must be removed; and

WHEREAS, it has been determined to modify Resolution No. 219521 by rescheduling the date from March 1, 1978 to August 1, 1978 for removal of all overhead utility facilities within the CAMINO DEL RIO SOUTH (Fairmount Avenue to Scheidler Way) UNDERGROUND UTILITY DISTRICT; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 219521 adopted October 19, 1977 be and it is hereby modified by rescheduling the date from March 1, 1978 to August 1, 1978 for removal of all overhead utility facilities within the CAMINO DEL RIO SOUTH (Fairmount Avenue to Scheidler Way) UNDERGROUND UTILITY DISTRICT.



2. That the City Clerk is hereby directed to give notice to all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code and all affected utility companies of the adoption of this Resolution No. 220637 within fifteen (15) days after the date of such adoption. The City Clerk shall specifically notify the affected persons that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall provide, at their own expense, all necessary facility changes on their premise so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California and subject to all other applicable requirements of State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.

3. The City Manager is hereby directed to give notice to such affected persons and affected utilities in accordance with Section 61.0511(b) of the San Diego Municipal Code.
