BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the second lowest bid of \$211,144 by PATRICK J. TIMMINS CONSTRUCTION INC, a corporation, for the CONSTRUCTION OF FIRE STATION #29 IMPROVEMENTS, Base Bid with Additive Alternate No. 1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. 762236.
2. That the expenditure of \$195,000 out of Third Year Block Grant Fund 2930, and \$38,444 out of Fourth Year Community Block Grant Fund Contingencies, and \$19,838 out of Capital Outlay Fund 245, of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
3. That the City Auditor be authorized to transfer \$38,444 out of 73.95 Fourth Year Community Block Grant Fund Contingencies to 73.56 - Fire Station 29.
