APPROVING MAP OF AZTEC FINANCIAL PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, a Registered Civil Engineer, entitled "AZTEC FINANCIAL PARK Being a subdivision of a portion of Pueblo Lot 1110 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, filed in the office of the County Recorder of San Diego County, November 14, 1921, and known as Miscellaneous Map No. 36." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under, upon and across a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.


