BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MISSION GORGE DEVELOPMENT COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of May 12, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all those portions of Lot 60, Rancho Mission of San Diego, according to the Partition Map thereof, made in Superior Court Case No. 348 and filed in the Office of the San Diego County Recorder as Map No. 330, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel E is hereby dedicated as and for a public street and the same is hereby named TIERRASANTA BOULEVARD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
