

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SHAPELL-LOMASANTAS PARTNERSHIP, a partnership, executed in favor of The City of San Diego, bearing date of January 30, 1978, conveying to said City a permanent easement and right of way for public streets, drainage purposes and incidents thereto to construct, reconstruct, maintain, operate, repair, together with the right of ingress and egress, over, under, upon, along and across all those portions of Lot "E", Referee's Partition Map of a portion of Lot 70, Rancho Mission of San Diego, filed in Superior Court Case No. 15191, and all those portions of Lot 38 of Rosedale Tract, according to Map thereof No. 825, filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel D is hereby dedicated as and for a public street and the same is hereby named TIERRASANTA BOULEVARD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
