BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of GARDEN VIEWS CONDOMINIUMS, a limited partnership, executed in favor of The City of San Diego, bearing date of March 23, 1978, conveying to said City a permanent easement and right of way for public street and incidents thereto over, under, upon, along and across that portion of Lots 64 and 65 of the Rancho Mission of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MISSION GORGE ROAD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
