WHEREAS, Assembly Bill No. 1862, effective January 1, 1978, amended the California Health and Safety Code so that cemetery lots which have remained inactive or unclaimed for a period of 50 or more years may be declared abandoned and reclaimed by The City of San Diego; and


WHEREAS, since there has been no contact or action regarding approximately 2,200 lots at Mt. Hope Cemetery sold between 1868 and 1924, and original records are inadequate for locating owners or other interested parties, and Assembly Bill No. 1862 authorizes The City of San Diego to reclaim these lots; and

WHEREAS, sales of reclaimed lots will provide The City with an additional source of revenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager and City Attorney are hereby authorized and directed to proceed, pursuant to Section 8136 of the Health and Safety Code of the State of California, with the action necessary to reclaim cemetery plots which have been abandoned at the Mt. Hope Cemetery.
