BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to use City forces to perform operational and repair work to provide water service in connection with the CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 41, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City forces than if let by contract, the cost of said work shall not exceed an additional \$48,000.
