WHEREAS, Penasquitos, Inc. presently owns approximately 273 acres in the City known as Rose Canyon; and


WHEREAS, The City is considering acquiring all or a portion of said 273 acres for open space park purposes; and

BE IT FURTHER RESOLVED, that the City Council hereby approves the sharing of the cost of the necessary appraisals for the City and the Penasquitos, Inc. properties.
