1. That the bid of \$15,905.40 by A-C COMPANY, a corporation, for the CONSTRUCTION OF MIRAMAR ROAD - OLD MIRAMAR ROAD TO CARROLL ROAD (BIKE PATH), in the City of San Diego, California, is hereby accepted and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. 762713.
2. That the expenditure of \$8,000.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$82,000 from C.I.P. 52-031.6 to the Gasoline Tax Unallocated Reserve C.I.P. 90-220.
