

RESOLUTION NO. 220690

WHEREAS, the Comprehensive Planning Organization (CPO) is comprised of fifteen (15) representatives from the fourteen (14) cities and the County of San Diego and was created pursuant to a Joint Powers Agreement; and

WHEREAS, CPO presently performs various regional functions within San Diego County and is presently recognized by the United States government as the Metropolitan Planning Organization for San Diego County for purposes of various federal statutes; and

WHEREAS, CPO is presently the Transportation Planning Agency for most transportation planning functions within San Diego County; and

WHEREAS, CPO has performed the above functions along with its other various regional and area-wide duties in commendable and efficient fashion; and

WHEREAS, Senate Bill 1746 (Mills), as introduced, would in essence abolish CPO and would designate for the area within the County, The County of San Diego as the sole and exclusive agency to perform regional and area-wide review or planning as required by federal statute; and

WHEREAS, The County of San Diego would be designated as the Transportation Planning Agency for the area included within San Diego County; and

WHEREAS, Senate Bill 1746 would remove from the 14 cities of San Diego County any decision-making authority in regard to regional and area-wide planning and would relegate them to an advisory position only; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Department of Legislative Representation is hereby directed to take all necessary action, for and on behalf of The City of San Diego, to declare the City's opposition to Senate Bill 1746 or any similar legislation.
